1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

The college came into existence by an order of Government of Chhattisgarh to start class B A part-1 B Com part-1 or Bsc part-1 from 2013. Since then, journey of the eight years running successful from its opening date 1-january 2013. Initially the college started in the old two rooms of govt. HSS Beloudi. The college was shifted to the present campus in near cow gothaan is in 2016. This journey gives the college tremendous scope and energy for continuing its dynamism in this fringe rural region.

In 2019-2020, the college had 502 student pursuing several undergraduate programms. The student admitted to UG courses are from heterogeneous and rural background. Nearly 90% student belongs to SC/ST/OBC categories amongst them most of the student comes under BPL income group. The education awereness in girls can be known from the fact that the gender ratio of the college is two third to that boys. We provide all the possible and feasible facilities to the girl student coming from far and nearby village and blocks. The institution is fully aware of its prime responsibility of mentoring these students by providing qwality in education to empower these student and motivate them by maintaining balance between tradition and modernity.

Apart from providing value based education and learning, the college strives hard to provide friendly atmosphere for over-all grooming and development of student by various co- curricular and extra co-curricular activities.

- Guest faculty appointment is also done by the Department of Higher Education. Govt. of Chhattisgarh on centrally controlled basis. These appointments are delayed and guest faculty join the college in the last week of august whereas teaching starts in the 1st week of July.
- Student comes from rural area, and there is less environment of teaching/coaching of subjects like chemistry, competition exams and English language.
- Lack of internet, ICT, Wi-Fi, computers and other Technical-support and concerned staff.
- UG lab is not sufficient. The practicals are done batch-wise.
- Inexistence of Digital library.
- Doesn't have Alumni base enough to create employment opportunities and create big funds.

Curricular Aspects

The Government naveen college beloudi provide basic and useful education to the rural area student with the best environment. The college is affiliated to the HEMCHAND YADAV UNIVERSITY, Durg Chhattisgarh. Institute follows the syllabus prescribe by the affiliating university. The college has three UG programs. These are B.A., B.Sc. and B.Com.in UG level. For these programs and courses, our college adopts the curriculum approved by the affiliated university. The university follows the model syllabi prescribed by UGC. The institute covers the curricular programmes within the time. Institute regularly organize the lectures of eminent educationalist, person and academician and also organize the national seminar, workshop on the different topic.. College has comprises ICT system that also help to cover the syllabus. Teaching with the LCD projector is the use of modern technology. College has the formal mechanism to monitor evaluate and implement to the curriculum aspect.

The college is sensitive to cross cutting social issues and makes every effort to sensitize the students by periodically organizing seminars/ extension lectures on Gender Equality, Environment and Sustainability, Human Values and Professional Ethics. There are specific committees and clubs that make a collective effort to raise the level of awareness amongst the students.

The college has developed a system where feedback is obtained from the stakeholders. These feedback are collected, analyzed and put in front of Principal to take suitable action as per the requirement.

Teaching-learning and Evaluation

The college strictly follows the academic calendar issued by the department of Higher Education, Govt. of Chhattisgarh. While most of the teaching is done with the blackboard, chalk and lecture method, the use of modern teaching aids like LCD projector and methods like group discussion, seminars, mock tests, question answer session, are also used in every accedmic year by the faculties. The college strictly follow the university planner and prepares academic calendar, which includes teaching-learning, evaluation, events and co-curricular activities schedules. All student notices, events, academic calendar and photographs are uploaded on the website on regular Teaching-learning and Evaluation The college is dedicated to enhance its academic excellence, basis.

The college maintains a student-centric and learner-centric atmosphere to achieve the desired learning outcomes. IT based facilities are used extensively for dissemination of knowledge and evaluation .Student's feedback on teachers and their teaching also plays an important role in the improvement of teaching skills of faculty . Research, Innovations and Extension

College has not recognized as the research centre and does not offer the research orientated courses. The college is committed to engage faculty members and students in research, innovation and extension activities.

The college has limited infrastructural facilities. The research facility is in preliminary stage, basic science laboratory is the best way to do research in institute. The research promotion committee always promote the research work. College regularly organizes the work shop, seminar which is highly beneficial for the research.

The college has YOUTH units through which we undertake extension activities in the neighborhood community which helps in the holistic development of students. Students are motivated to actively participate in Extension activities through awareness programs ,Rallies ,Road shows etc. In this way they are helping the under privileged section of the society.

Infrastructure and Learning Resources

Government naveen college beloudi was established in the year 2013-14 to provide quality education. The college is affiliated to Hemchand Yadav University Durg . College has all necessary but not sufficient infrastructures. Total area of college is 8 acre and construction area is 10k sq. feet .The college has its own campus, in which there is double flour building .

Though adequate facilities for indoor games are available but for outdoor games, the grounds of other agencies are engaged. ICT facilities in the institution are in the developing stage though the teaching staff use ICT enabled methods for academic purposes. The Library has a good collection of about 15,000 books and subscribes 1 journals to enable the students to acquire knowledge and for research purposes. There is a good collection of rare books. Efforts are being made for the automation of the library. The percentage of usage of library by teachers and students is also satisfactory. Maintenance of the equipment of laboratories are carried out from time to time to keepup the infrastructural facilities and promote the use of the same.

Student Support and Progression

he college is committed to excel by extending academic, financial, professional and psychological assistance to every student. Liberal concessions, Government and Non- Government scholarships are provided to needy students.

The college provides guidance for competitive exams, career counseling, remedial coaching, and personal counseling for enhancement of capabilities of students. The college has a Career Counseling Cell to guide students regarding career avenues. A Strong Student Grievance Redressal Committee and Anti-Ragging Committee have been established to redress student's grievances.

The State Government provides financial assistance to the students belonging to SC/ST/OBC category and more than 45% of them receive scholarship. Differently-abled students are also given facilities to bring about social equity. The College provides guidance for competitive examination through Career Counseling Cell and Personal counseling through Happiness Cell.

There is a strong discipline committee which keeps strict vigil on students. Anti-ragging committee, Anti-ragging squad, Sexual harassment cell, grievance redressal cell are active to redress the college related grievances of the students. A complaint box is placed in front of office. For woman empowerment and ethical matters a healthy atmosphere is maintained.

Governance, Leadership and Management

A democratic and decentralized approach in administration provides ample opportunity to the staff and students to develop the quality of leadership. A close monitoring of academic, administrative and financial management ensures the optimum utilization of the resources. The college administration always strives to achieve academic and administrative excellence to ensure expansion to physical infrastructure.

College is under the state government, the policy, management and governance is managed by the department of higher education Chhattisgarh government. The budget allocation, teaching and non teaching post appointment, welfare schemes, infrastructure development fund and all the major decision taken by the department of higher education. The aim of college is to create education environment and holistic situation for the effective implementation of the policy and management of higher education. For improvement of grooming leadership of the student as well as teacher college run YOUTH wings.

Category-III includes "Research and academic contribution" having no boundary of marks. Category-IV includes "Summary of the API" to be filled by the teaching faculty. Another type of evaluation is called the secret-report of the employee. It Is filled by all the teaching and non-teaching employees. It generally has two parts. The first part is filled by the employee. The last part is the evaluation by the Principal. It is then sent to higher authority of the Higher Education Department of Chattisgarh Government.
